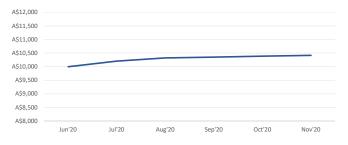

GROWTH OF \$10,000 SINCE INCEPTION⁽²⁾

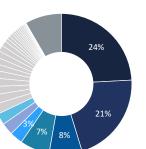
