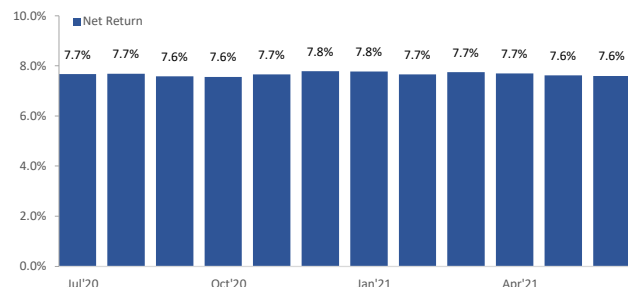

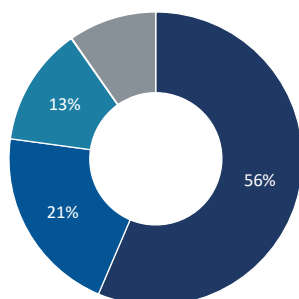
## TRAILING 12-MONTHS RETURNS

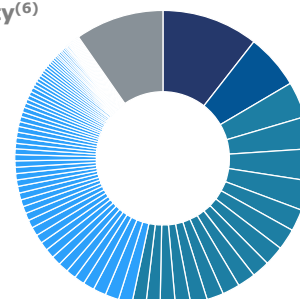
